- 1. Roll Call: Rebecca Wisnoskie absent.
- 2. November 2018 Minutes approved by Board
- 3. Attorney J. Olcott is present to answer questions from DM1 board about the upcoming Annual meeting and election of board members.
  - A. Discussion of how to handle any Write in Ballots. Lorna spoke about what is included in mailing to members. Dave Palmer also spoke about what he believes should be in mailing.
  - B. Discussion of how to handle Write in Ballots and changes to CCR's
  - C. Olcott says a Quorum at Annual Meeting must have at least 99 returned ballots for a vote to take place. 67 % percent must vote in the Affirmative to change the CCR's. It is also required that the above Quorum exist for any floor vote at the Annual Meeting. If more than 99 members ballots are returned then the 67% would be of the total returned.
  - D. Olcott says Directors must resign in writing and may extend if no replacement, until a later date. DM1 board members can be filled by Affirmative vote of board members at a Organizational Meeting immediately after the Annual Meeting on Jan. 10<sup>th</sup>, 2019. Election of DM1 board officers can take place at the same time.
  - E. Olcott discussed changing the number of required board of directors. 5 members constitute a Quorum. He also discussed whether we should consider changing BYLAWS. He has a sample copy to use as a template.
  - F. Olcott said that a Notice of Annual Meeting and a Organizational Meeting must be sent out to all members.
